## **NOTICE OF PUBLIC HEARING**

All interested parties are hereby given notice that the City of Edmond and Oklahoma County District 3, in cooperation with the Oklahoma Department of Transportation (ODOT), proposes to widen and reconstruct Covell Road from State Highway 74 to Interstate 35. The consulting firm of Triad Design Group, hired by the City and County to perform an environmental analysis of the proposed improvements, has scheduled a public hearing to discuss the project.

The proposed project extends approximately 9.25 miles from roughly State Highway 74 to I-35. The proposed project segment located within the Corporate Limits of the City of Edmond (7.25 miles) includes widening the existing two-lane Covell Road facility to a four-lane separated boulevard with ADA compliant multipurpose paths on both sides. The proposed project segment located within the unincorporated area of Oklahoma County (2 miles) includes widening the existing roadway to a four-lane undivided curb and gutter facility. Covell Road will be built in phases due to the length and costs of the overall project.

The Public Hearing will be held at 6:00 pm, Thursday, November 13<sup>th</sup>, 2008 in the Parks Department Room at 2733 Marilyn Williams Drive, Edmond, Oklahoma. Representatives from the City of Edmond, Oklahoma County, ODOT, and Triad Design Group will be in attendance. Concerned citizens will have the opportunity to comment on the Environmental Assessment as completed.

The Environmental Assessment will be available for inspection at City Hall located at 24 East First Street in Edmond, The Edmond Public Library at 10 S. Boulevard in Edmond, or the Parks Department Building in Mitch Park, 2733 Marilyn Williams Drive in Edmond.

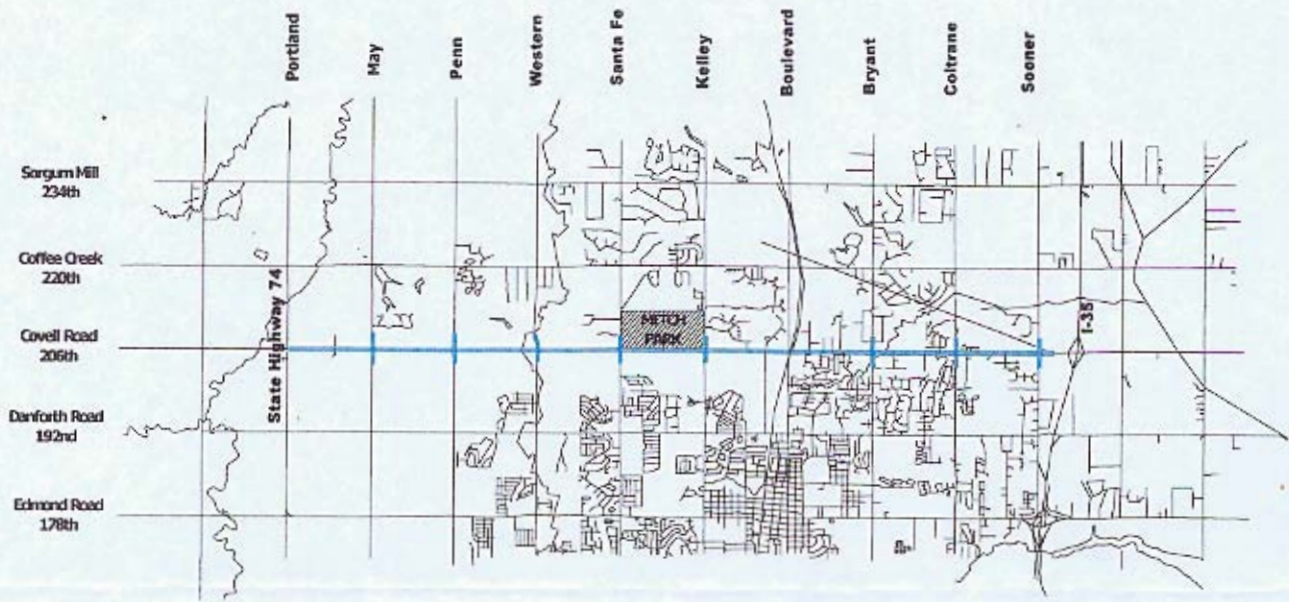
